TERMS & CONDITIONS

- This interdistrict transfer agreement/permit is valid only for the school year granted. The agreement/permit expires at the end of each school year and **must be renewed annually**.
- All interdistrict approvals are conditional upon students following all school rules and regulations; this includes good attendance (90% attendance and no more than ten (10) tardies), appropriate behavior (no more than ten (10) discipline points per semester and no Level C offenses) and satisfactory academic performance (maintain a minimum of 2.0 GPA). In the event of a problem in any of these areas, the HJUHS D may revoke this interdistrict agreement.
- Approval is subject to space availability in the district of desired attendance and may not be at the requested school site.

I declare, under penalty of perjury under the laws of California, that the information provided above is true and accurate. I have read the terms and conditions set forth above and understand the interdistrict transfer regulations and policies. I understand that if approved, this permit is subject to the terms and conditions above and that this permit may be denied or revoked during the school year based on any violation of the terms and conditions set forth herein.

This Agreement is made between the Governing Boards of the resident and requested school districts pursuant to the following terms and conditions:

1. The district of attendance agrees to accept for the school year ending **June 30**, _____, in so far as facilities permit, the herein named pupil(s) from the district of residence and to furnish the pupil(s) the same advantages, equipment, supplies and services as furnished to other pupils in attendance in the district of attendance. At the end of the above school year this agreement shall terminate except for payment of any sums remaining due under paragraph three.
2. The district of attendance reserves the absolute right to terminate this agreement upon fifteen (15) days written notice to the district of residence. The district of residence has no right to terminate this agreement during its term absent breach of the agreement by the district of attendance.
3. The A.D.A. for the pupil(s) named herein shall be credited to the district of attendance as stated in Education Code Section 46607.
